## **Conversation guide for traveling with a Diplomatic Passport.**

Dear,

With my Diplomatic Passport I show that I have beneficially accepted my Birth Trust legacy and that I have corrected my DAS status of my natural person into the State of Living Man (m/f). As a result, I am an autonomous diplomat and diplomatically inviolable.

From the position of Living Man (m/f) I appeal to the Vienna Convention on diplomatic communication that says I am free to travel without restrictions and to reside in every state. These are all territories in Europe and beyond.

And I appeal to the Universal Human Rights and in particular:

### **Art. 13 UDHR**

1. Everyone has the right to move and reside freely within the borders of each State.
2. Everyone has the right to leave any country, including his own, and to return to his country.

### **Art. 20 UDHR**

1. Everyone has the right to freedom of peaceful association and assembly.
2. No one should be forced to belong to an association.

The Dutch State Company does not have a professional contract with me as an autonomous resident of the territory and therefore the Dutch State Enterprise cannot subject me to the COVID-19 company measures, company clothing regulations and the corporate crisis protocol topics. Your 'government' does not have a professional contract with me either. Security regulations of private company managements that are allegedly public service, may not force the Living Man (m/f) to join their companies nor comply with company safety regulations by subjecting the Living Man (m/f).

**I therefore have the right to travel and to stay without restrictions and without conditions on every territory.**

## **Uitzonderingen verplichting negatieve testuitslag**

De volgende mensen hebben geen negatieve testuitslag nodig:

- Houders van een door het ministerie van Buitenlandse Zaken verstrekte diplomatieke identiteitskaart.
- Houders van niet-Nederlandse diplomatieke paspoorten.
- Houders van Nederlandse diplomatieke paspoorten, als zij in uitoefening van hun functie reizen of als zij van of naar hun werkzaamheden reizen.
- Staatshoofden en leden van een buitenlandse regering.

You ask me to identify myself and then I show and identify myself with my Diplomatic Passport as:  
[Christening Name(s)] Vdf [Family Name].

In this Diplomatic Passport you will find the track and trace shipping codes of the Inheritance Documents sent by me to the government agencies of the State of the Netherlands. You can inquire with these government agencies including H.M. King Willem-Alexander.
